TO THE ARTICLES OF INCORPORATION OF
TEXAS ASSOCIATION FOR EDUCATIONAL DATA SYSTEMS JAN 04 1988
CHARTER NUMBER 487809

Corporations Section

Pursuant to the provisions of Article 1396-4.03 of the Texas Non-Profit Corporation Act, Texas Association for Educational Data Systems, a Texas nonprofit corporation which is subject to the provisions of the Texas Non-Profit Corporation Act, adopts the hereinafter stated Articles of Amendment to it Articles of Incorporation, which: will change its name to the Association for Computer Educators in Texas.

ATRICLE I

NAME

The name of the corporation is Texas Association for Educational Data Systems.

ARTICLE II

SPECIFICATION OF AMENDMENT

The following amendment to the Articles of Incorporation was adopted by the corporation on October 25, 1987.

The name of the Texas Association for Educational Data Systems and all references to the name be changed to read the Association for Computer Educators in Texas.

ARTICLE III

HOW ADOPTED

The amendment was adopted at a meeting of members held on October 25, 1987, at which a quorum was present, and the amendment received at least two-thirds of the votes which members present or represented by proxy at such meeting were entitled to cast.
